

附录 - 6 个关键的道德问题



- Is there any slave or forced labour used? 有否使用任何奴役或強迫勞動?
- Is there any child labour under the age of 15 years used? 是否使用 15 歲以下的童工?(如果是中國工廠,有否使用16歲以下的童工?)
- What are the average number of working hours per week for workers? 工人每週的平均工作時間是多少?
- Do you expect workers to work over 60 hours per week? 工人每週工作有超過 60 小時嗎?
- Do you provide breaks for workers? How long are the breaks? 你們有為工人提供休息時間嗎?休息時間是多少?
- Do you have contracts with reputable international retailers and can you confirm who they are? Do you have any other recognized international certification on ethical standards you can share? 您有否與國際知名零售商的業務往來,能提供他們的名稱嗎?您是否有任何其他國際公認的道德/社會合規審核認證可以與我們分享?
